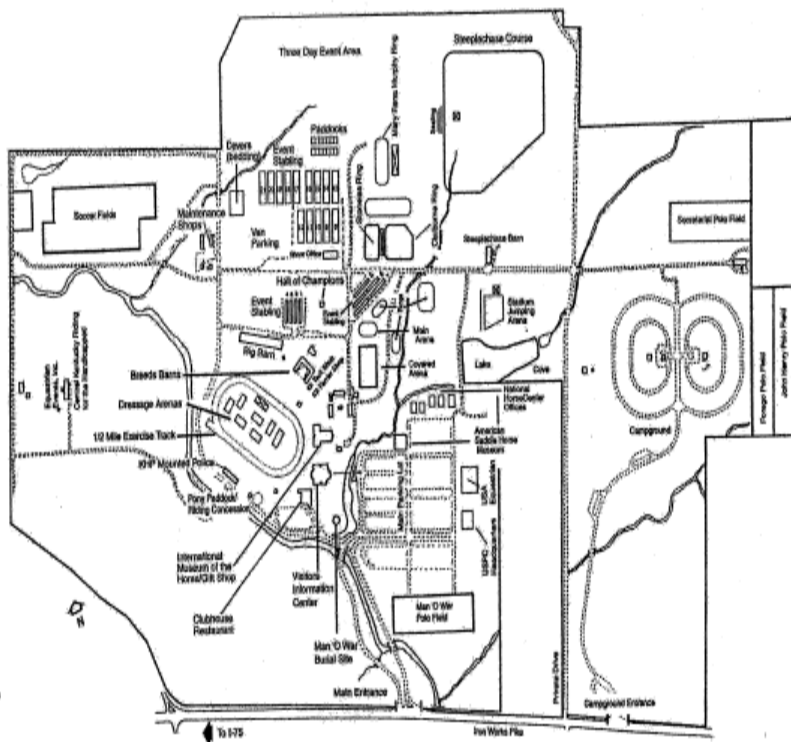

# **REGULATIONS PERTAINING TO GOLF CARTS / ATV'S / MOTOR VEHICLES**

## **1. PRIVATELY OWNED GOLF CARTS**

A Kentucky Horse Park Golf Cart User License Decal must be purchased to operate the golf cart within the Kentucky Horse Park. (Must have a valid driver's license) **THE LICENSE COST; \$50.00 FOR THE SEASON**

## **2. ATV'S / 4 WHEELERS / 3 WHEELERS / DIRT BIKES**

Off-road type motorcycles are not permitted anywhere on the Kentucky Horse Park (STRICTLY ENFORCED). **EXEMPT VEHICLES ARE KHP LAW ENFORCEMENT, FIRE & MEDICAL PERSONNEL**

**3. Golf cart license can be purchased at the CAMPGROUND STORE and DEVER INC.** (located in the show area).

## **4. PER KENTUCKY STATUTES**

The operator of any motor vehicle (electric, gas, diesel) must be at least 16 years of age and have a valid operator's license.

**KRS 186-620 Unlawful to drive or permit another to drive without a license.**

(per Fayette County District Court / \*minimum fine \$159, includes \$135.50 mandatory court cost)

**KRS: 189.040 (front lights) KRS: 189.050 (rear lights)**

**AFTER DARK (Night-low light)** the vehicle must have a working head light and tail light

## **PLEASE NOTICE!**

**GOLF CARTS / MOPEDS, ETC** – A privilege, not a right, extended to show participants. You must be at least 16 years of age with a valid driver's license to operate these vehicles. Not allowed in the Tourist / Visitor areas of the Park. A Golf Cart License is required for all private golf-carts and can be obtained for \$20 per event / or \$50 for the season from the Golf Cart Vendor office. **NO ALL TERRAIN VEHICLES (ATV) ARE ALLOWED ON HORSE SHOW GROUNDS! USEF Rule GR 1301.7**

## **MOTORIZED VEHICLES (see GR1301.7):**

7. Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

8. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. BOD 1/12/19 Effective 4/1/19

**BARN CALLS!** Entries must be prepared and report to the makeup area at least 10 minutes prior to the class in which they are entered. Kentucky Fall Classic will make every effort to announce the progress of the preceding class over speakers to the stable area. Barn calls are a courtesy of the show. It is the responsibility of the exhibitor to present your horse prior to the gate closing.

# ALL HORSES MUST HAVE CURRENT HEALTH CERTIFICATES

**COGGINS TESTS:** Proof of negative Coggins within the past 12 months is required of every horse entering the show grounds. A copy of the test results should be attached to the entry form; otherwise, they must be presented to the Secretary upon arrival. NO ENTRY WILL BE ACCEPTED WITHOUT CURRENT TEST RESULTS.

## USEF GR 845

1. All horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within 6 months prior to entering the property. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of the vaccine administration should be per the vaccine manufacturers' or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian.
2. In the case of vaccines administered by a veterinarian, the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian documenting that the horse in question received the vaccinations, the name of the vaccines and date of vaccine administration.
3. In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of vaccine purchase which is signed by the owner, or agent with care, custody and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration.
4. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon requests by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds. The log of temperatures should be provided to the Competition Management, steward, or technical delegate when requested.

**VETERINARIAN:** Dr. Ashley Craig from Haygard Equine Medical Institute, Lexington, Kentucky will serve as the official Horse Show Veterinarian Service and will inspect such horses designated by the judge(s) or steward to be considered unsound and will pass on any question pertaining to the soundness of any horse before being excused from the class. Her decision will be final. Dr. Craig will be available at (859) 255-8741 and additional contact telephone numbers will be posted on the door of the Horse Show office for after show hours.

**RECEIVING YOUR BACK NUMBERS, YOU WILL NEED –** Copy of the original papers showing correct owner, USEF member card for owner, trainer, exhibitor, appropriate membership card for Breed organizations, measurement card for ponies, Social Security or Federal Tax ID number for payee. *Back numbers will not be issued until all paper work is complete.*

#### **RULES AND REGULATIONS**

ALL OWNERS AND EXHIBITORS WILL BE RESPONSIBLE FOR ANY DAMAGE OR INJURY CAUSED OR CONTRIBUTED TO BY THEM, THEIR AGENTS OR THEIR ANIMALS TO BARNES OR OTHER PROPERTIES AND TO PERSONS ON THE SHOW GROUNDS AND WILL BE BILLED ACCORDINGLY. IN NO INCIDENT WILL THE KENTUCKY HORSE PARK OR THE UPHA CHAPTER 9 KENTUCKY FALL CLASSIC HORSE SHOW BE HELD RESPONSIBLE FOR ANY LOSS OR DAMAGE IN ACCIDENTS OR DAMAGE TO PERSONS OR ANIMALS OR LIABLE FOR ANY INJURY SUSTAINED IN ANY WAY TO EXHIBITORS, SPECTATORS, EMPLOYEES OR ANY OTHER INTERESTED PARTIES. NOR WILL THE KENTUCKY HORSE PARK OR THE UPHA CHAPTER 9 KENTUCKY FALL CLASSIC HORSE SHOW AND ITS MANAGEMENT BE RESPONSIBLE FOR ANY ARTICLES LOST OR STOLEN. IT WILL BE THE CONDITIONS OF ANY ENTRY AT THE UPHA CHAPTER 9 KENTUCKY FALL CLASSIC TO HOLD BLAMELESS ANY PARTIES CONNECTED TO THE SHOW FOR ANY TYPE OF LOSS.

EVERY CLASS OFFERED HEREIN, WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULEBOOK, WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.

**ENTRY DEADLINE:** All Entries close **September 16, 2019**. Entries postmarked after this date will be charged post entry fees regardless of qualification date.

**POST ENTRIES: REGULAR FEE PLUS \$10** per entry from September 16 until 2 hours prior to Show each day.

**ENTRIES CAN NOT BE ACCEPTED UNLESS ACCOMPANIED BY PAYMENT INCLUDING STALL FEES. STALLS WILL NOT BE RESERVED WITHOUT PAYMENT IN FULL**

**OPEN ACCOUNTS:** There will be no open charge accounts without an open check or credit card on file in the office.

**ONE-HORSE PER ENTRY FORM** Entries must be completed on entry forms furnished by the UPHA Chapter 9 Kentucky Fall Classic Horse Show.

**PLEASE TYPE OR PRINT. HORSES MUST BE ENTERED BY THEIR REGISTERED NAME AND CORRECT OWNERSHIP.** Copies of registration papers are required.

**YOUR SOCIAL SECURITY OR FEDERAL TAX ID NUMBER IS REQUIRED TO RECEIVE PREMIUM CHECK**

**USEF membership number** is required for owner, trainer, exhibitor, handler, lessee, agent or coach; as well as any other association membership numbers required for breeds and disciplines.

**All Entries** are required to have a Certificate of Equine Infectious Anemia Test (Coggins Test) within the past twelve (12) months as required by the Kentucky State Veterinarian. No exceptions. ALL HORSES MUST HAVE A HEALTH CERTIFICATE issued by a veterinarian within the past 120 days with a temperature on each animal.

**STALLS:** Horse and tack stalls are \$150 each for the entire show. Grounds Fee NO FIRST BEDDING PROVIDED. All stalls are 10 X 10 pvc panel permanent box stalls equipped with sliding doors and equimix asphalt flooring. . Early ship in stalls available at \$50 per day.

**CONTROL OF HORSES:** Horses must be kept under control at all times. At the discretion of the judges and/or steward, horses may not be allowed to compete. Owner will forfeit entry fees.

**COURTESY TO OFFICIALS:** Any act of discourtesy to the judges on the part of any exhibitor, owner, trainer or groom shall disqualify the horse and rider. The owner shall forfeit his entry fees and any prize money won at this show; and, subjects himself to be reported to the USEF. During the time of judging, no person will be allowed in the ring except ring attendants, judge(s) of the class and when necessary the handler in charge of the horse being judged. Attendants or grooms will enter the ring in suitable attire only. Headers may enter the ring by the end gate only and must take no actions that will affect the performance of any animal in the class. Exhibitors must receive permission from the Steward to approach the judge.

**USEF FEE:** In compliance with the USEF rules, a **\$23.00 fee will be collected on all horses entered including equitation horses (\$15 Drugs & Medications Fee; \$8 USEF Fee).** Please include on the entry blank.

**USEF AMATEUR CARDS (GR1307) – All competing amateurs must have USEF Membership with Amateur status indicated.**

#### **USEF MEMBERSHIP STATEMENT**

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR218) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

**UNITED STATES EQUESTRIAN FEDERATION MEMBERSHIP:** All owners, trainers, riders must have a current United States Equestrian Federation (USEF) card or pay a USEF Show Pass fee.

**AMERICAN SADDLEBRED HORSE ASSOCIATION MEMBERSHIP:** All owners and trainers of American Saddlebred horses must be members of the American Saddlebred Horse Association (ASHA). You can contact them at 859-259-2742 for questions regarding your membership.

**UNITED PROFESSIONAL HORSEMAN'S ASSOCIATION MEMBERSHIP:** A Professional trainer of a UPHA Classic entry must be an Active member of UPHA and the current owner of the entry needs to be an Associate member of UPHA and the membership numbers must appear on the entry form. If a non-professional is exhibiting the horse they must be an Associate or Junior member of the UPHA. All exhibitors showing in Challenge Cup Classes must be Junior Members of UPHA.

**AMERICAN HACKNEY HORSE SOCIETY MEMBERSHIP:** Owners and trainers of ponies participating at Federation licensed competitions in any Hackney section must be current members in good standing with the American Hackney Horse Society and provide an original or copy of the AHHS membership card unless the competition, at their discretion, confirms electronically with the AHHS office. Lessees are considered owners in connection with this membership requirement. In the event of an entry with multiple owners, only one owner need be a member of AHHS.

**PONY MEASUREMENTS:** Numbers will not be issued without a current measurement card. Every pony must have a current card or form issued by the USEF or CEF and must present it to the Show Secretary. Please include copies, if possible, with entry.

**TIME OUTS:** Only one (1) 5-minute timeout may be requested per exhibitor per class. In case of casting a shoe or breakage of equipment in the paddock, the gate may be held no more than 3 minutes. There will be no delay after the first horse enters the ring, at which time the gate will be held for 2 minutes.

**THE HORSE SHOW COMMITTEE** decision shall be final and shall decide all questions not covered in these rules and regulations.

**CANCELLATION/SCRATCHES:** Exhibitors canceling their entries after the official closing for any reason shall forfeit the accumulation of entry and stall fees. All scratching of horses at the show must be done at the show office one hour before the start of the session in which they are to compete. **PLEASE MAKE SCRATCHES EARLY AND BE CONSIDERATE TO OTHER EXHIBITORS.**

**RING DIMENSIONS:** Show Ring 135 feet x 309 feet –clay/river sand mix footing – Indoor Show Arena with Indoor Make up Area.

**PAYMENT OF PREMIUMS:** All prize money will be paid by check drawn to the order of the payee as listed on the entry blank. Checks will be forwarded by mail within 30 days after the show. SOCIAL SECURITY NUMBER OF THE PAYEE MUST BE INCLUDED ON ENTRY FORM BEFORE PAYMENTS ARE MADE.

Attention getting devices &/or other noisemakers (including but not limited to tape measures, blow horns, bamboo poles, explosives, fire extinguishers, baby powder, whips longer than 6', etc.) are not allowed in and around the make up and competition rings during scheduled competition sessions or at any times designated by Competition Management. All such items will be confiscated and offenders will be reported to the USEF. (See also GR839.4j)

**SHARPS CONTAINERS - GR1210.4.** Competition management shall place a minimum of one sharps container per each competition, whether or not stabling is provided. Additionally, at least one sharps container per fifty occupied stalls for the disposal of needles and other disposable sharp instruments in convenient locations in barns housing competition horses. It is competition management's responsibility to replace such containers when full and dispose of them properly. Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. Competition management will place a notice of this requirement either in its prize list or on a specific handout given to trainers on check in at the competition. If local law has different requirements, local law will prevail. Competitions failing to comply with placing the required number of containers on the show grounds will be considered in violation of the rules and may be subject to penalty as determined by the CEO or his designee and/or the Hearing Committee.

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR218) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

The purpose of **The Bluegrass Futurity Hunter Classic** is to promote the versatility of the American Saddlebred and increase the marketing of "less showy" performance horses.

This class is open only to Registered American Saddlebred horses that are competing during their first or second competition years as Hunter Country Pleasure horses, according to the records of the American Saddlebred Horse Association. Horses in this class may be shown by a professional, amateur or junior exhibitor. To be shown at a walk, trot, extended trot, canter and hand gallop both ways of the ring. For safety reasons, judge may limit the number of horses required to hand gallop at one time. Entries must be asked both ways of the ring to halt and stand quietly on the rail. To be judged on suitability as a Hunter, manners, performance, quality and conformation. In the line, horses must stand quietly with all four legs perpendicular to the ground. Horse shall be required to back readily in the line.

A non-refundable eligibility fee of \$150 paid to **THE BLUEGRASS FUTURITY** postmarked on or before Sept 15 of each year. After Sept 15, the eligibility fee becomes \$250 per horse. Payment of the eligibility fee will be made payable to **THE BLUEGRASS FUTURITY** in the name of the entered horse and will make that animal eligible to compete in **THE BLUEGRASS FUTURITY HUNTER CLASSIC** at The Kentucky Fall Classic Horse Show. Eligibility remains with the animal throughout the year should transfer of ownership occur. Eligibility Fees collected will be used as prize money in **THE BLUEGRASS FUTURITY HUNTER CLASSIC**. An entry fee of \$50 is due upon entering class at The Kentucky Fall Classic. All entry fees are added to the total purse of the class.

Every person who has reached his/her 18th birthday and competes in classes for amateurs under Federation rules must possess current amateur status issued by the Federation. (Exception: This is not required for Opportunity classes except for the Dressage Division. If Opportunity classes are offered at Dressage Competitions or Regular/Local Competitions with "Open" Dressage classes and are restricted to amateurs, riders are required to have amateur status with the Federation). This status must be available for inspection or the competitor must have lodged with the competition secretary, at least one hour prior to such class, an application for such status provided by the Federation. Amateur status will be issued only on receipt of the application properly signed and is revocable at any time for cause. Foreign riders requesting Federation Amateur status, must be a Junior, Senior or Life Competing Member of the Federation (Exception: Equestrian Canada members in possession of current EC membership may sign for USEF Amateur status on a show by show basis at no cost). Any person who has not reached his/her 18th birthday is an amateur and does not require amateur status.

**Dogs (see GR1301.6):** Dogs are not permitted to be loose on competition grounds and must be held on a leash or otherwise restrained. Individuals must not lead dogs on a leash while mounted. Dog owners are solely responsible for any damages, claims, losses or actions resulting from their dogs' behaviors. Dog owners failing to comply with this rule will be issued a Yellow warning card may be subject to penalty under Chapters 6 and 7.

## **Bluegrass Select Series Championship**

In keeping with the ASHA's initiative of creating a Select Series of classes around the country for beginning and intermediate level horses and riders/drivers, the Bluegrass Select Series will be held in Kentucky this year, starting with the Kentucky Spring Premier Horse Show.

This program features a series of classes held at designated Kentucky shows. These classes are designed for those horses not showing at the World's Championship Horse Show to have a place to show against the same level horses, riders and drivers. There will be championship classes for this series to be held at the Kentucky Fall Classic with prizes and awards above the normal trophies and ribbons.

To be in the program an exhibitor must declare that their horse will not show at the World's Championship Horse Show in that year, under their ownership. If the horse does show at Louisville it will NOT be eligible for the Bluegrass Select Series Championship classes and year-end awards. Also, to be eligible for the Championship classes a horse must have shown in at least (1) classes at (1) different shows.

The classes offered will include Fine Harness, Three Gaited Park, Amateur/Junior Exhibitor Five-Gaited, Amateur Junior/Exhibitor Three-Gaited, Adult/Junior Exhibitor Five-Gaited Show Pleasure, Adult/Junior Exhibitor Three-Gaited Show Pleasure, Adult/Junior Exhibitor Country Pleasure, Open Roadster to Bike and Open Saddle Seat Equitation.

Qualifying class where held at the Kentucky Spring Premier, Rock Creek, Mercer County Fair, Woodford County, and the Rock Creek Novice Show. The championships for the Series will be held at the Kentucky Fall Classic.

## ADHHA SHOW RULES

Updated 7-8-2017

### **General Rules:**

In order to compete, all horses must be registered with the American Dutch Harness Horse Association (ADHHA). Horses recorded with ADHHA are not eligible to compete in ADHHA sanctioned classes.

### **Type and Conformation:**

The American Dutch Harness Horse is a powerful, expressive, high-action, animated horse of great character developed primarily for driving. The ideal is a horse of high quality, upright self-carriage, happiness, correctness of limbs and feet, soundness and suspension with high, open flexing front end motion driven by powerful impulsion from behind. The head should be attractive with alert eyes and ears. The well-muscled, arching neck is set on high with a flexible poll. The shoulder is clean and well laid back on to prominent withers that are higher than the back and croup. Croup should be neither too at or too sloping and never inverted. Body is proportionate to horse's height and hindquarter shall have a powerful presentation. Legs are straight, clean and strong with well-muscled forearms and gaskins. Feet are large and round with well-sprung heels. Tail is carried high and straight.

### **In Hand Classes:**

The American Dutch Harness Horse should possess conformation that is functional for its job. Known as a powerful driving horse, the trot must have a lot of suspension; high, open motion in front and forceful impulsion from behind.

**Appointments:** to be shown in a suitable show halter or lead bridle and led individually. Weanlings must show without their dams in the ring.

**To be judged:** on performance, conformation, and presence at the walk and at the trot. How shown: to enter the ring at a trot, showing the horse to its best advantage; then return to the judge for conformation inspection. Horse to stand naturally for inspection. At the completion of inspection, horse is then to walk to the lineup. Two handlers allowed per horse; each handler may carry a whip. Whips may have small, unobtrusive bags or ribbons attached.

**Classes offered:** Mares, Stallions, and Geldings. These classes may be divided by age if management deems necessary.

**Open** – may be divided into Mares, Stallions and Geldings Junior – for horses 4 years of age and under

**Novice** – horses not to have won 3 blue ribbons at the close of entries

**Limit** – horses that have not won 6 blue ribbons at the close of entries

**Junior, Limit and Novice** classes may be combined at the discretion of show management and the agreement of all exhibitors concerned if management combines classes during the show.

**Ladies, Gentleman, Amateur and Junior Exhibitor** classes may also be offered. **Championship:** Must have qualified in a previous class at the same show.

**Attire:** handlers should be neatly and appropriately attired, no blue jeans, shorts or t-shirts.

## **Harness Classes:**

**Appointments** - Harness: Dutch Harness Horses may be shown in Traditional Dutch Harness, Hackney-style harness or fine harness. Hackney-style harness consists of Liverpool bit, separate check bit, black leather, round blinds, side check, at lines, at traces, low crupper or tail spoon. Fine harness consists of a snaffle bit, separate overcheck bit, black leather, square blinds, overdraw, martingale, round lines and round traces. No item may be used to alter natural ear usage.

**Vehicles:** Hackney-style harness shown to a viceroi. Fine harness shown to a four-wheeled, side bar buggy. All vehicles and equipment must be in serviceable condition. Any exhibitor using vehicles or equipment deemed to be disruptive to other exhibitors must be excused from the ring. Not Allowed: Antique vehicles, Liverpools with martingales, and boots.

**Gaits:** To be shown at an “animated walk,” “park trot” and “show your horse.”

**Animated Walk:** Highly collected, springy and energetic.

**Park Trot:** Collected trot showing animation and brilliance. Show Your Horse: Designates the speed which shows the horse to its best advantage. Extension of gait is a distinctive characteristic of the breed; however, excessive speed and loss of form should be penalized.

**How shown:** To enter the ring at a “park trot” in the counter clockwise direction, to “show your horse” when called for, then to the “animated walk” before reversing. Reverse at the animated walk. To show both ways of the ring at the same gaits. Horses may be unchecked in the lineup or during a workout. Headers are optional. Headers should be suitably attired, no blue jeans, shorts or t-shirts.

**To be judged:** on performance, conformation, quality and manners. Horses shall not be asked to back.

Classes offered: Mares, Stallions, and Geldings. These classes may be divided by age if management deems necessary.

**Open** – may be divided into Mares, Stallions and Geldings Junior – for horses 4 years of age and under

**Novice** – horses not to have won 3 blue ribbons at the close of entries Limit – horses that have not won 6 blue ribbons at the close of entries

**Junior, Limit and Novice** classes may be combined at the discretion of show management and the agreement of all exhibitors concerned if management combines classes during the show.

**Ladies, Gentleman, Amateur and Junior Exhibitor** classes may also be offered. Championship: Must have qualified in a previous class at the same show.

Attire: Traditional show attire.

## **Roadster:**

The fast, cadenced, in-form trot is the hallmark of a Roadster horse. The horse shall be asked to trot at three different speeds: the jog trot, the road gait and then at speed. At all gaits, the horse should perform in form and under control. Mixey-gaited horses that pace, or rack the turn, or that break and run shall be penalized. Exhibitors executing gaits that are not called for must be penalized.

## **Appointments:**

Black leather, square blinds, overcheck, snaffle bit, check bit, martingale and boots. Shown to a two-wheel road bike. No racing bikes.

For Under Saddle classes horse to be ridden, the saddle should be of English-type with leather or web girth, martingale with a single or double reins, and a single bit bridle with cavesson.

In Bike and Under Saddle classes exhibitors to wear stable colors, i.e. cap (for protective head gear) and jacket to match (racing silks). Number to be worn on the exhibitor’s back.

**How shown:** Roadsters must enter ring in the clockwise direction at a jog trot, then shown at the road gait, return to the jog and reverse, show at the jog, the road gait and the trot to speed.

**How judged:** To be judged on performance, speed, quality and manners.



**Classes offered:** Roadster to Bike Open, Roadster Under Saddle

**Championship:** Must have qualified in a previous class at the same show.

**Park Under saddle Classes:** The ADHHA Under Saddle Horse should be stylish with finish and quality. The performance should be animated and graceful in all gaits. Horses may show with a braided or full mane with natural tail carriage.

**Appointments:** A double bridle consisting of snaffle and curb (double bridle) is preferred or Pelham bit with 2 reins, with curb chain or leather curb strap. No horse shall be shown with a snaffle bit only, breast plate, tie-down or martingale. The saddle should be of English-type with leather or web girth.

**Gait Requirements:** To be shown at “animated walk”, “trot” and “canter”.

**How shown:** To enter the ring at a “park trot” in the counter clockwise direction, then to the “animated walk” and calling for the “canter”. Calls for the “canter” from the “park trot” are not permitted. Reverse may be called at “animated walk”, “park trot” or “reverse and trot”. To show both ways of the ring at the same gaits.

**Animated Walk:** Highly collected, springy and energetic. **Park Trot:** Collected trot showing animation and brilliance. **Canter:** Correct leads are imperative. Incorrect leads are to be penalized.

**To be judged:** To be judged on performance, presence, quality, manners and conformation.

**Classes Offered:** Mares, Stallions, and Geldings. These classes may be divided by age if management deems necessary.

**Open** – may be divided into Mares, Stallions and Geldings Junior – for horses 4 years of age and under

**Novice** – horses not to have won 3 blue ribbons at the close of entries Limit – horses that have not won 6 blue ribbons at the close of entries Junior, Limit and Novice classes may be combined at the discretion of show management and the agreement of all exhibitors concerned if management combines classes during the show. Ladies, Gentleman, Amateur and Junior Exhibitor classes may also be offered.

**Championship:** Must have qualified in a previous class at the same show.

**Attire:** Informal Saddle Seat attire for riders is required in morning and afternoon classes. Formal Saddle Seat attire or dark colored habit (with collars and lapels of same color) and accessories are optional for evening. Gaudy colors should be avoided.

**Amateur:** A person is an amateur regardless of one’s equestrian skills and/or accomplishments, so long as they are not engaged in any equine services deemed as a trainer and/or instructor identified as a professional working for monetary gain as a means of livelihood.

**\*If you cross enter divisions i.e. ADHHA to any USEF/Open sanctioned classes, USEF rules will apply including the USEF general rules.**

**\*Chains at any public event are prohibited.**

## Kentucky State Academy Rules

**Attire of the rider:** Jodhpurs, vests, tie and long sleeved shirt, with riding boots and gloves. Hair should be neatly held back so that the back number is visible. Riding suits and hats are prohibited. Protective headgear is strongly encouraged.

**Equipment for the horse:** School bridles, double or full bridles with running martingales and German martingales are all permissible along with appropriate saddle for the division being judged. Any protective equipment (shin boots, knee boots, rundowns, saddle pads, etc.) will be permitted. Blunt spurs are optional at the discretion of the instructor. No braiding of the horse; hoof blacking is optional. Training devices such as chains, stretchers, and blinkers are NOT allowed in the warm up ring or the show ring.

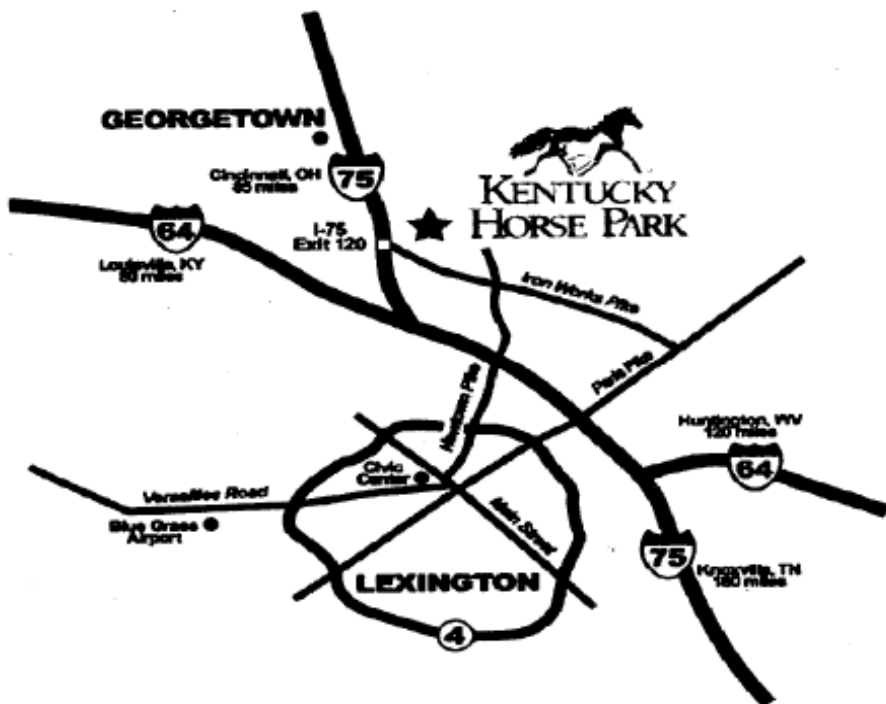
**Class Divisions and Judging Criteria:** There should be two main divisions – Equitation which is to be judged on basic seat, hands and form, along with effective control of the horse. Pleasure classes to be judged on showmanship, ring generalship and presentation of the horse to its best ability. Correct diagonals are not to be judged in the pleasure classes. Classes should be further divided into walk/trot and age divisions.

**Rider Eligibility:** A rider is no longer eligible for the academy division if he/she has shown, dressed in a riding suit in a regular horse show class; with the exception of competing in a 4-H Horse Show. This applies to riders that compete in a suit in the walk/trot division – they cannot then compete in the walk/trot/canter academy division.

**Horse Eligibility:** A horse that is used in an academy competition can be farm or privately owned and must earn its living in a lesson program. It cannot be maintained in training within the current show season.

**Cross Entering:** Academy horses (with different riders) are permitted to cross enter in regular classes of a show as long as they meet the academy criteria. If an academy rider competes in a regular class at a show he/she is ineligible for further competition in the academy division.

**ACADEMY ENTRIES CLOSE OCTOBER 1, 2019**



The Kentucky Horse Park is located 4 miles north of Lexington, and 3 miles south of Georgetown, at I-75, exit 120.

**From Downtown Lexington:** Travel north on Newtown Pike (992) to Iron Works Pike (approximately 9 miles) and turn left. Traveling west in approximately 2 miles The Kentucky Horse Park entrance will be on the right-hand side of the road.

**From Knoxville, Tennessee:** Travel north on I-75 (approximately 173 miles) and take exit 120. Turn right at the top of the ramp turn right onto Iron Works Pike in about .5 miles the Kentucky Horse Park entrance will be on the left-hand side of the road.

**From Charleston, West Virginia:** Travel west on I-64 (approximately 168 miles) to I-75 north and take exit 120. Turn right at the top of the ramp turn right onto Iron Works Pike in about .5 miles the Kentucky Horse Park entrance will be on the left-hand side of the road.

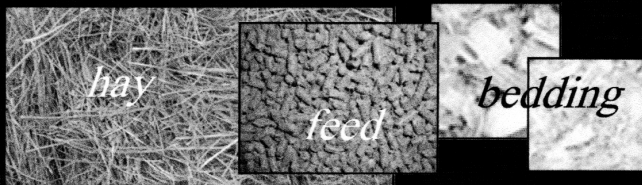
## TOP 10 RULES

### **INFORMATION MUST BE POSTED IN EVENT PRIZE LIST OR COMPETITOR**

#### **INFORMATION**

1. **PARKING** - Passes may be obtained from the Parking Booth or Visitor Information Center upon entry. **\$15.00** fee assessed for each **parking pass** per event. All trailers must park in approved lot. **NO PARKING** is allowed in the barn area. Trailers should be dropped in the appropriate parking lot and **NOT** in the stabling area.
2. **CAMPING**- Must go to campground for all camping, unless event has made separate arrangements with KHP Special Events. **NO CAMPING ALLOWED IN BARN AREA AT ANY TIME!** **CAMPING**- Please call 888/4KY-PARK (888/459-7275) or reserve on-line at [www.parks.ky.gov](http://www.parks.ky.gov). Groups of 20 or more, please call 859/259-4257 or 800/370-6416. Check-out time is at noon. Violators will be towed.
3. **GOLF CARTS/ MOPEDS ETC.** - A privilege-*not a right*- extended to show participants. Must be at least 16 years of age with valid driver's license. **Not allowed in the tourist/visitor areas of the Park. NO ALL TERRAIN (4-wheeler, 3-wheeler, dirt bikes over 50 cc's) VEHICLES ARE ALLOWED ON HORSE SHOW GROUNDS!**
4. **DOGS**- Must be on a leash (not to exceed 6 feet in length) or suitably restrained in a tack stall/cage etc. Loose animals/ animals left in vehicles in distress, etc. can and will be removed from the grounds at the owner's expense.
5. **HORSES AND HORSE DRAWN VEHICLES / STABLING** – Horse and carriages have the right-of-way at all times. Competitors must comply with contracted ship-in and ship-out dates.
6. **EXHIBITOR PROBLEMS/SPECIAL REQUESTS**-All non-emergency problems or special requests *must* be relayed through show management to ensure prompt attention.
7. **PACKAGES/DELIVERIES**- The Park is **not** responsible for any deliveries to an event or event participant. All packages are delivered to Central Receiving at the Maintenance Complex; addressee is responsible for retrieving packages. Park mail service personnel will try to assist if conditions allow, however, any delivery/package may be refused/returned to sender, etc at any time without notification.
8. **PARK ADMISSION**- Reduced Park admission is available to event participants and must be obtained at the Visitor Information Center.
9. **FIRE CODES** – As of May 15, 2006, The Kentucky Horse Park will not allow the following inside of barns or tents, which will be enforced by the Fire Marshal:
  - a. any 2-wire appliances
  - b. any 2-wire extension cords
  - c. light duty cords for indoor use
  - d. any 3-way adaptors unless specifically made for outdoors
  - e. any adaptors without 3-wire connections
  - f. any cut or damaged cords
10. **EVENT MANAGEMENT** is responsible for notifying/ making available all Park rules/regulations to participants in their event. Included, but not limited to, exhibitors, officials and volunteers.
